

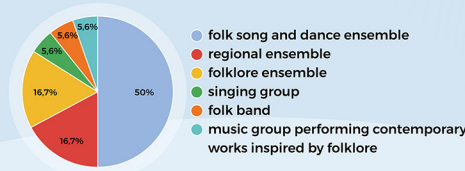

## Source Project for FAIR Analysis

**FolkArtNet** Folk music groups: their artistic practice and infrastructural needs in the COVID-19 era and beyond  
**Funding:** DARIAH-ERIC Theme 2020: Arts Exchanges  
**Duration:** 1 year  
**Goal:** establishing cooperation with the community of Polish folk music artists and identifying their needs in regard to ICT  
**Methodology:** online interviews, survey and workshop  
**Motivation:** digital preservation of intangible cultural heritage created by Polish folk music groups (551 groups active worldwide)  
**Results:** qualitative data characterizing infrastructural requirements of folk groups

## Study Participants



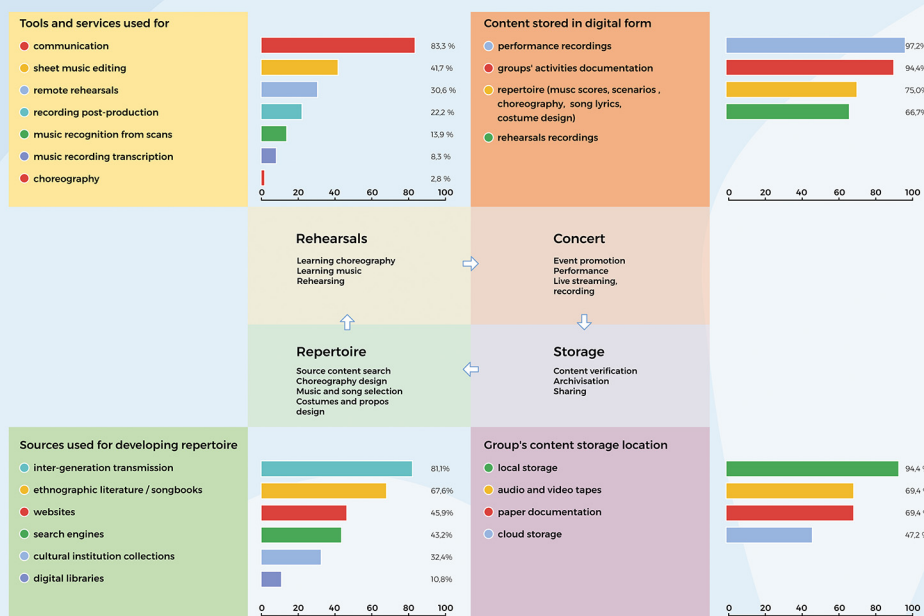
36 survey respondents from Poland and abroad by folk group type

## Investigation Areas and Survey Results



## Key Findings

Facts	Description	Prioritization	
Repertoire	73% ensembles use online resources	Online sources of ethnographic content are used by some ensembles for repertoire creation, however, such sources should be further promoted.	Must have reliable data repositories for finding source materials Could have easy-to-use project management platform
Rehearsals	Only 30% ensembles rehears remotely	Few ensembles rehearsed remotely and if they did it was only because the pandemic made traditional rehearsals impossible.	Must have tools for remote rehearsals during social distancing as a replacement of rehearsals <i>in situ</i> Could have tools for remote rehearsals as a supplement to live rehearsals
Concert	Only 52% ensembles had concerts recorded professionally	The ensembles record performances by themselves, however, few of these recordings are publicly available due to quality issues.	Should have video and sound editing software Could have professional AV equipment
Storage	Only 47% ensembles use cloud based repositories	The ensembles' resources are seldom stored in trustworthy repositories, even though most folk artists recognize the need to document their activities as a part of intangible cultural heritage.	Must have secure and trustworthy storage space for keeping digital assets Could have public access to stored data

The ensembles widely use social media for organizing activities, promoting events and publishing content that documents their work.

## Conclusions and FAIRification Perspectives

- Data related to folk groups' artistic practice, i.e. fieldwork and artistic event documentation, should be *Findable, Accessible, Interoperable and Reusable* by humans and machines.
- Such content is rarely stored in trustworthy repositories and published online for rediscovery due to:
  - lack of awareness of the existing technical solutions that could facilitate more structured online storing and sharing
  - available applications and services not meeting expectations (lack some crucial features, immature, unaffordable)
  - lack of long term strategy for preserving accumulated digital assets
  - insufficient manpower and technical skillset available to manage digital resources (voluntary membership)
- There is a clear need for
  - ICT systems that would implement FAIR principles starting with *Findable*
  - socio-cultural change in folk practitioners attitudes towards technical standards and best practices in managing digital assets (GO CHANGE GO BUILD)
